

SDK RUNTIME LICENSE AGREEMENT FOR INOVIX INC. SOFTWARE

SOFTWARE PRODUCT(S) LICENSED:

- Inovix Fingerprint SDK
- Inovix Image SDK
- Inovix Verification Capture SDK
- Inovix Enrollment Capture SDK

TYPE OF RUNTIME LICENSE:

- Perpetual, cost per seat RUNTIME license + first year upgrades
- Perpetual, RUNTIME free / Royalty free License + first year upgrades.

IMPORTANT -- PLEASE REVIEW THE FOLLOWING TERMS AND CONDITIONS CAREFULLY. This Inovix Inc. Runtime SDK License Agreement ('RTSDKLA') is a legally binding contract between you and Inovix Inc. for the Inovix Inc. software product(s) and license type identified above, which product(s) includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By downloading, installing, copying, or otherwise using the SOFTWARE PRODUCT, you acknowledge that you have read and understand this RTSDKLA and agree to be bound by its terms and conditions.

FOR ELECTRONIC MEDIA PURCHASERS: BY OPENING THE SEALED MEDIA PACKAGE, YOU INDICATE YOUR ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS RTSDKLA. IN THE EVENT THAT YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, YOU SHOULD PROMPTLY RETURN THE PACKAGE UNOPENED TO THE AUTHORIZED DEALER FROM WHOM YOU OBTAINED THIS SOFTWARE PRODUCT, WITH PROOF OF PAYMENT, FOR A REFUND.

FOR ONLINE PURCHASERS: YOU WILL NOT BE PERMITTED TO ACCESS AND DOWNLOAD INOVIX INC. SOFTWARE PRODUCT WITHOUT FIRST READING AND ACCEPTING THE TERMS AND CONDITIONS OF THIS SDKLA.

1. Notification of Copyright. All title and copyright in and to the SOFTWARE PRODUCT is owned by Inovix Inc. and/or its licensors and is protected by United States copyright laws and international treaty provisions. Inovix Inc. retains all ownership rights in the SOFTWARE PRODUCT. The copyright notice must be reproduced and included on any copy that is expressly permitted under this RTSDKLA.

2. Grant of License.

A) GENERAL TERMS THAT APPLY TO DERIVATIVE PRODUCTS AND REDISTRIBUTABLES

Inovix Inc. grants Licensee a perpetual nonexclusive right to reproduce and distribute the Inovix SDK Runtime and Sample Code as contained in the "examples" directory ("Redistributables") for execution on any operating System or hardware. Copies of Redistributables may only be distributed with and for the sole purpose of using the Derivative Product(s) that Licensee has created with the SOFTWARE PRODUCT subject to the terms and conditions of this Agreement. Under no circumstances may any copies of Redistributables be distributed separately of Derivative Product(s).

The license granted in this Agreement for Licensee to create Derivative Product(s) and distribute them and the Redistributables (if any) to Licensee's customers is subject to all of the following conditions:

- i) All copies of the Derivative Product(s) Licensee creates must bear a valid copyright notice, either Licensee's own or the copyright notice that appears on the SOFTWARE PRODUCT;
- ii) Licensee may not remove or alter any copyright, trademark or other proprietary rights notice contained in any portion of the SOFTWARE PRODUCT;
- iii) Redistributables, if any, shall be licensed to Licensee's customer "as is";
- iv) Licensee will indemnify and hold Inovix Inc., its related companies and its suppliers, harmless from and against any claims or liabilities arising out of the use, reproduction or distribution of Licensee Derivative Product(s);
- v) The parts of the Derivative Product(s) that are developed and use the SOFTWARE PRODUCT must be developed with a licensed and registered non-evaluation copy of the SOFTWARE PRODUCT SDK;
- vi) Derivative Product(s) developed by the Licensee must add primary and substantial functionality to the SOFTWARE PRODUCT over that of the SOFTWARE PRODUCT in such a manner that such Derivative Product(s) shall not be intended as a commercially acceptable substitute for the SOFTWARE PRODUCT or be competitive with products of the general type as the SOFTWARE PRODUCT.
- vii) Derivative Product(s) may not pass on functionality which in any way makes it possible for others to create software with the SOFTWARE PRODUCT;
- viii) Licensee may not use Inovix Inc.'s or any of its suppliers' names, logos, or trademarks to market Derivative Product(s), except to state that Derivative Product(s) was developed using SOFTWARE PRODUCT;
- ix) Where Redistributables are supplied to a third party as part of client software the Licensee must not disclose his personal SDK unlocking code or in any way make it possible for others to create software with the SOFTWARE PRODUCT.
- x) Support and updates: Inovix Inc. provides limited e-mail support and free updates and upgrades for one year. Other than this services, Inovix Inc. provides no technical support as part of this license.

B. Definition of "Use." A copy of the SOFTWARE PRODUCT is "in use" in a computer when it is loaded into the temporary memory (i.e., RAM) or is installed into the permanent memory (e.g., hard disk, CD-ROM, or other storage device) of that computer.

C. Additional Rights. Inovix Inc. further grants to you the right to: (a) make one copy of the SOFTWARE PRODUCT in an electronic media solely for backup or archival purposes, or (b) transfer the SOFTWARE PRODUCT in an electronic media to a single hard disk; provided, that you keep the originals solely for backup or archival purposes. You may not copy any printed materials that are included with the SOFTWARE PRODUCT. Copyright laws prohibit the making of additional copies of the SOFTWARE PRODUCT for any other reason.

3. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

- i) Rental. You may not rent, lease or lend the SOFTWARE PRODUCT.
- ii) Software Transfer. You may permanently transfer all of your rights under this RTSDKLA, provided you retain no copies, you transfer all of the SOFTWARE PRODUCT (including all component parts, the media and printed materials, any upgrades, this RTSDLLA, and, if applicable, the Certificate of Authenticity, and the recipient agrees to the terms of this RTSDKLA. If the SOFTWARE PRODUCT is an upgrade, any

transfer must include all prior versions of the SOFTWARE PRODUCT.

4. Updates/Upgrades. If the SOFTWARE PRODUCT is labeled or otherwise identified by Inovix Inc. as an "update" or "upgrade," you must be properly licensed to use a product identified by Inovix Inc. as being eligible for the update/upgrade in order to use the SOFTWARE PRODUCT. A SOFTWARE PRODUCT labeled or otherwise identified by Inovix Inc. as an "update" or "upgrade" replaces and/or supplements the product that formed the basis for your eligibility for such update/upgrade. You may use the resulting updated/upgraded product only in accordance with the terms of this RTSDKLA. If the SOFTWARE PRODUCT is an update/upgrade of a component of a package of software programs that you licensed as a single product, the SOFTWARE PRODUCT may be used and transferred only as part of that single product package and may not be separated for use on more than one computer.

5. Termination. This license and your right to use the SOFTWARE PRODUCT (i) automatically terminate if you fail to comply with any provision of this RTSDKLA. Upon termination, you must destroy the SOFTWARE PRODUCT and any copies that you have made. Inovix Inc. retains all rights not expressly granted, and nothing in this RTSDKLA constitutes a waiver of Inovix Inc.'s rights under copyright laws or any other federal or state law or treaty.

6. LIMITED WARRANTY. Inovix Inc. warrants that the SOFTWARE PRODUCT will substantially conform, as to all material operational features, to Inovix Inc.'s applicable standard written specifications, provided that it is used on the computer hardware and with the operating system for which it is designed, and will be free from error that substantially adversely affects performance for a period of ninety (90) days from the date of purchase. This limited warranty shall not apply to any SOFTWARE PRODUCT that Inovix Inc. determines has been subject to misuse, neglect, improper installation, repair, alteration, or damage by you. EXCEPT FOR THE FOREGOING LIMITED WARRANTY, Inovix Inc. MAKES NO WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, WITH RESPECT TO THE SOFTWARE PRODUCT INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, QUIET ENJOYMENT AND NON-INFRINGEMENT. If by law there are any implied warranties, they are likewise limited to ninety (90) days from the date of purchase. You assume responsibility for the selection of the SOFTWARE PRODUCT and hardware to achieve your intended results; and for the installation, use and results obtained from the SOFTWARE PRODUCT. Inovix Inc. makes no warranty as to any license keys, if any, issued in connection with the license of the SOFTWARE PRODUCT. Should the distribution media contain information and/or technology that either are owned by third parties or in the public domain, Inovix Inc. makes no warranties or representations as to such information and/or technology and further disclaims any and all liability for any losses or damages that may result from your use thereof.

7. Customer Remedies. Inovix Inc.'s entire liability and your exclusive remedy shall be, at Inovix Inc.'s option, one of the following: (a) attempt to correct or help you around significant errors with efforts that Inovix Inc. believes to be suitable to redress the error; (b) repair or replace the SOFTWARE PRODUCT that does not meet Inovix Inc.'s Limited Warranty with functionally equivalent software; or (c) refund the license fee and terminate this RTSDKLA. Your remedy is conditioned upon your return of the SOFTWARE PRODUCT to Inovix Inc. with a copy of your proof of purchase within ninety (90) days of the original purchase. Any replacement SOFTWARE PRODUCT will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

8. LIMITATION OF DAMAGES. IN NO EVENT WILL INOVIX INC. BE LIABLE TO YOU FOR DIRECT OR INDIRECT DAMAGES, INCLUDING ANY LOSS OF PROFITS, LOST SAVINGS, LOSS OF DATA, OR OTHER SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF YOUR USE OF OR INABILITY TO USE THE SOFTWARE PRODUCT, EVEN IF INOVIX INC. OR AN AUTHORIZED INOVIX INC. REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE AND EVEN IF THE REMEDIES PROVIDED IN THIS AGREEMENT FAIL OF THEIR ESSENTIAL PURPOSE. IN NO EVENT WILL INOVIX INC.'S LIABILITY EXCEED THE AMOUNT OF THE LICENSE FEE. INOVIX INC. WILL NOT BE LIABLE FOR ANY CLAIM BY A THIRD PARTY. BECAUSE SOME

STATES AND COUNTRIES DO NOT ALLOW THE EXCLUSION OR LIMITATIONS OF CONSEQUENTIAL OR INCIDENTAL DAMAGES OR IMPLIED WARRANTIES, THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. THE WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY DEPENDING ON THE STATE OR COUNTRY.

9. Governing Law. This RTSDKLA is governed by the laws of the State of New Jersey, U.S.A., and the United States, including patent and copyright laws. This RTSDKLA will not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. If any provision of this RTSDKLA is held to be illegal, invalid, or unenforceable then that provision shall be fully severable from this RTSDKLA and shall not affect the legality, validity or enforceability of the remaining provisions of this RTSDKLA.

10. Export Restrictions. You agree to comply with all applicable export control laws and with any regulations issued from time to time by the United States Department of Commerce and similar agencies of other countries concerning exporting, importing, and re-exporting software. You further agree that the SOFTWARE PRODUCT will not be acquired, shipped, transferred or exported, directly or indirectly, into any country or used in any manner prohibited by the United States Export Administration Act and the regulations thereunder, or will be used for any purpose prohibited thereby.

11. International Users. This SDKLA has been written in the English language. You waive any rights that you may have under the laws of your country for this RTSDKLA to be written in the language of that country. The remedies and limited warranty offered by Inovix Inc. are not available without proof of purchase from an authorized United States or International source.

12. U.S. Government Restricted Rights. The SOFTWARE PRODUCT is provided with RESTRICTED AND LIMITED RIGHTS. Use, duplication, or disclosure by the Government is subject to restrictions as set forth in subparagraph (b) (3) of the Rights in Technical Data and Computer Software clause as DFARS 252.227-7013 or subparagraphs (c) (1) and (2) of the Commercial Computer Software-Restricted Rights at 48 CFR 52.227-19, as applicable, and any amendments thereto.

YOU ACKNOWLEDGE THAT YOU HAVE READ THIS RTSDKLA, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS; YOU FURTHER AGREE THAT IT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE AGREEMENT BETWEEN US WHICH SUPERSEDES ANY PROPOSAL OR PRIOR AGREEMENT, ORAL OR WRITTEN, AND ANY OTHER COMMUNICATIONS BETWEEN US RELATING TO THE SUBJECT MATTER OF THIS RTSDKLA. THIS AGREEMENT SHALL PREVAIL NOTWITHSTANDING ANY DIFFERENT, CONFLICTING, OR ADDITIONAL TERMS AND CONDITIONS WHICH MAY APPEAR IN ANY PURCHASE ORDER OR DOCUMENT SUBMITTED BY LICENSEE.
